IT is hereby notified that the Minister of Industry and Commerce, in terms of section 4(1)(a) of the Control of Goods (Import and Export) (Commerce) Regulations, 1974, published in Rhodesia Government Notice 766 of 1974, hereby makes the following notice:—

1. This notice shall be cited as the Control of Goods (Open General Import Licence) Standards Assessment–Consignment Based Conformity Assessment (CBCA) Notice, 2024.

2. The Control of Goods (Open General Import Licence) (Standards Assessment) Notice, 2015, published in Statutory Instrument 132 of 2015, is repealed.

3. These regulations shall come into force on the date of publication of this notice.

*Interpretation*

4. In this notice—

“assessment” means confirmation, through the provision of objective evidence, that requirements of the applicable standards have been fulfilled through one or more of the following tasks: shipment inspection, verification of documentation, sample testing and risk assessment;

“Conformity Assessment Body” means a company appointed by the Minister of Industry and Commerce to offer specialised verification of conformity services on behalf of the Government of Zimbabwe;

“certificate of conformity” means a verifiable document issued by the Conformity Assessment Body which is proof that the products specified therein conform to the prescribed standards;

“country of origin” means any country other than Zimbabwe, from which goods intended for shipment to Zimbabwe are either dispatched or assessed.

“destination inspection” means conformity assessment done within Zimbabwe at the port of entry or at any other premises permissible by the Minister;

“Free on Board (FOB) value” has the meaning accorded to it in terms of the Customs and Excise Act [*Chapter 23:02*];

“non-conformity report” means a report issued by the Conformity Assessment Body which is a statement that the products specified therein do not conform to the prescribed standards.

“relevant authorities” includes the Ministry of Industry and Commerce, Environmental Management Agency and Radiation Protection Authority of Zimbabwe.

*Application*

5. Subject to any other law in Zimbabwe, this notice shall apply to any person who imports the goods specified in the Fourth Schedule with a Free on Board Value of more than one thousand United States dollars (US\$1 000) or its equivalent.

5A. Notwithstanding the above provision, the following goods shall be subject to Consignment Based Conformity Assessment irrespective of Free-on-Board value—

*Assessment*

6. (1) The assessment of goods shall be conducted in the country of origin by the appointed Conformity Assessment Body.

(2) Any goods listed in the First Schedule and Second Schedule that arrive in Zimbabwe without a Certificate of Conformity shall be liable to a compulsory destination assessment process prior to final customs clearance.

(3) An importer whose consignment is assessed in terms of subsection (2) shall, in addition to inspection fees pay to the Treasury Department a penalty fee of 12% of the CIF value of the consignment.

(4) It is the duty of both the importer and the exporter to ensure that goods liable for assessment in terms of this section have been assessed by the Conformity Assessment Body.

(5) The exporter of the specified goods shall be liable to pay assessment fees to the Conformity Assessment Body specified in the Second Schedule.

*Procedure*

7. (1) An importer or exporter seeking a consignment-based conformity certificate shall submit a formal application to the designated Conformity Assessment body.

(2) The application shall be completed in its entirety and include the following information:

- (i) Importer's details (name, address, contact information).
- (ii) Exporter details (name, address, contact information).
- (iii) Location of the goods to be inspected.

- (iv) Detailed product description includes but not limited to list of goods, technical specifications, drawings and schematics).
- (v) Information on the production process and quality management system “QMS” where available.
- (vi) Conformity documentation related to the products (test reports, certificates of analysis and or any other relevant documents).
- (vii) Any other specific requests depending on the nature of the products.

(3)—

- (a) payment of the assessment fee, as specified in the Third and Fourth Schedules;
- (b) additional fees may be applicable based on additional testing requirements, and inspection requirements.

(4) The Designated Conformity Assessment Body inspects the goods as per the applicable technical regulations and standards.

(5) Upon completion of the assessment, the Conformity Assessment Body shall:

- (a) issue a consignment-based conformity Assessment Certificate if the good meets all specified requirements.
- (b) issue a Non-Conformity Report if the good fails to meet the specified requirements.

*Destination inspections*

8. (1) Goods arriving at the point of entry without the required certificate of conformity shall be subject to destination assessment and to a penalty fee of 12% of the CIF value payable to the Treasury Department.

(2) Where any goods are supposed to be assessed at their destination, the importer shall at his or her cost, move the goods to a bonded warehouse or any other suitable location to allow their assessment.

(3) The importer of goods referred to in subsection (1) may in addition to the penalty fee be subjected to sampling, transportation and testing fees.

(4) Expenses relating to storage, demurrage, unloading of the container or truck, handling of goods for assessments, and any other costs related to the assessment on arrival shall be borne by the importer.

(5) The testing and inspection costs will be met by the importer.

(6) Inspection fees by destination inspection providers shall be in accordance with the Third Schedule.

(7) ZIMRA shall, after consultation with relevant authorities, destroy substandard goods that fail to meet Destination Inspection requirements.

(8) Any costs for the destruction of substandard goods shall be borne by the importer.

#### *Certificate of Conformity*

9. (1) The Conformity Assessment Body shall issue a Certificate of Conformity for goods which have been assessed and are compliant with the prescribed standards.

(2) The Certificate of Conformity shall be made available to the exporter and, or importer after the assessment inspection.

(3) Where goods assessed are not compliant with the national and international standards, the Conformity Assessment Body shall at the conclusion of the assessment issue a Non Conformity Report to the exporter or importer.

#### *Non-compliance*

10. Any goods issued with a Non-Conformity Report shall be exported back to the country of origin or destroyed at the cost of the importer or where applicable by the relevant authorities at the cost of the importer.

*Exemption*

11. (1) The Minister may exempt any imports from the provisions of this order if he or she deems it within the national interest to do so.

(2) United Nations (UN) organisations and Diplomatic Missions are exempted from the CBCA Programme as they are signatories to the Vienna Convention.

For the avoidance of doubt, the description of goods under each tariff heading is not exhaustive of all the goods indicated under the First and Fourth Schedule. The tariff headings shall constitute the conclusive basis on determination of regulated goods.
