IT is hereby notified that the Minister of Youth, Sport, Arts and Recreation, has, in terms of section 34 of the National Arts Council Act [*Chapter 25:07*], made the following regulations:—

1. These regulations may be cited as the National Arts Council of Zimbabwe (General)(Amendment) Regulations, 2023 (No. 3).
