## COLLECTIVE BARGAINING AGREEMENT: SALARIES AND WAGES: TOBACCO (MISCELLANEOUS) SECCTOR

### Amendment to the Principal Agreement

This further agreement is made and entered into in accordance with the provisions of the Labour Act [*Chapter 28:01*] between the Tobacco (Miscellaneous) Industry Employers' Association (hereinafter referred to as the "the employers"), of the one part, and the Zimbabwe Tobacco Industrial Workers' Union (hereinafter referred to as "the employees" or the "trade union"), of the other part, being parties to the National Employment Council for the Tobacco Industry, to amend the Collective Bargaining Agreement for the Tobacco (Miscelleneous) Industry, published in Statutory Instrument 25 of 2018, as amended (hereinafter referred to as "the principal agreement") shall be read as one with the principal agreement.

This further agreement shall be deemed to have come into effect on 1st July, 2023, and is applicable up to 31st December, 2023. Grade minimums have been agreed for the period with the minimum set at US\$326,50. The wages are indexed to the US\$. NEC and Trade Union levies shall be remitted at a minimum of 80% in US\$. Employers who are paying more than 80% of the wage in US\$ are encouraged to continue doing so. The remainder thereof shall be converted from US\$ to ZWL\$ using the Willing Buyer Willing Seller Rate on the 15th of each month or on the Thursday before the 15th if the 15th is on a Friday or a weekend. The NEC shall provide, in every month, schedules of the applicable wages rates in ZWL\$. In addition, it has been agreed

by the Employment Council that the basic wage of an employee is an all-inclusive wage, inclusive of allowances, i.e., housing and transport. In addition, it has been agreed by the Employment Council that this does not preclude employers and employees at company level Works Council to improve on conditions of service.
